MOORAGE RULES

Owner meaning you, the client

SHVL meaning us, Sunshine Houseboat Vacations Ltd.

1. All Vessels approaching, using, or leaving the Floating dock, shall do so in a cautious and seaman-like manner, so as not to roll up swell, or do damage to other craft or property. Speed shall not exceed three (3) knots.
2. Each Owner is responsible for the safe mooring of his/her boat. Owners shall furnish and maintain their own safe line and charring gear. Chaffing gear shall be attached to the boat only and not to the Floats. Owners are responsible for periodically checking their boats, lines and fenders to ensure that they are secure.
3. Owners are responsible for periodically checking their boats, lines and fenders to ensure that they are secure.
4. Security is the responsibility of the boat Owners. All cabins must be locked when the Owner is absent, and nothing should be left in such a way as to invite theft or vandalism.
5. Major restoration or maintenance projects are not to be undertaken on a Wharf in the Marina. Owners may carry out routine maintenance work, but no litter is to be thrown overboard or left on the premises. The storage of flammable liquids, oily rags, etc. is prohibited.
6. All wharves must be kept free of personal property at all times.
7. Boats may not be unofficially posted for sale at the Sunshine Marina. With the Permission of SHVL, any moorage client craft advertised for sale at the SHVL marina will be subject to a 5% commission payable to SHVL on sales made by the craft owner, and an 8% commission on any craft sold with the direct assistance of SHVL.
8. Any Vessel Moored at a Wharf without authorization will be towed away at the Owner's expense.
9. Children under the age of 14 years shall not be permitted on a Wharf unless accompanied by an adult.
10. Dogs are prohibited on a Wharf unless on a leash under the control of the Owner.
11. Boat Owners and guests must conduct themselves in a manner conducive to the safety of the harbour and the quiet enjoyment of others.
12. No person shall cause any Live Aboard, Vessel or Watercraft to Moor or to remain Moored overnight or remain in a Water-lot Area without written permission of the Wharf Manager.
13. No person shall secure the Berth of any Vessel or Watercraft to the Wharf by use of a lock or otherwise in a manner that prevents the Wharf Manager from relocating the Vessel or Watercraft.
14. When safe to do so, when required by limited Mooring space, any person in charge of a Vessel or Watercraft may Raft the Vessel or Watercraft, provided that no more than two Vessels or Watercraft are Rafted.
15. Sanitary services are available. Vessels using the Marina must be equipped with holding tanks with the exception of runabouts and other smaller craft.
16. The maintenance and safety of Vessels open to the public shall remain the responsibility of the Vessel Owner.
17. Vessel Owners are not permitted to charge a fee nor solicit donations for any purposes without the consent of the Wharf Manager.
18. All Vessels must be clearly marked, with the name or registration number as required by law.
19. NO SMOKING is permitted on Sunshine Houseboat Docks, inside or near any buildings.

BORDER CROSSING

LAKE KOOCANUSA IS NOT A LEGAL POINT OF ENTRY INTO EITHER COUNTRY (CANADA OR USA)

It is illegal to cruise into the USA. It is illegal to land, moor, anchor, or meet another boat on the USA side of the border on Lake Kooconusa. Please note that the USA Border Patrol, Sheriff's Department and/or The Department of Fish and Wildlife and/or The Department of Forestry have the legal right to fine \$10,000 U.S. for illegal entry.

The customer hereby releases SHVL from any and all such claims for damage or loss to personal property and chattels in, on or about the premises and hereby waives all rights or recovery against SHVL in connection with any damage which is or would be covered by such insurance. To the extent that the customer does not maintain the required insurance coverage for the full value of such personal property the customer shall be deemed to have been self insured.
